This early funding will probably be raised by way of 'Pioneer Shares' which later convert to ordinary community shares, but which by nature of the project are at higher risk of not being returned to the so-called pioneer investors. The 'pioneer shares' idea was operated by the Anglers Rest CBS that we visited last weekend.
